MMMPO UPDATES AND NEWS

Mileground Road Update:

The Mileground Road widening project has been ongoing since 2019. Work to widen the 1.08-mile section of road was paid for through Gov. Jim Justice's \$2.8 billion Roads to Prosperity program. It serves as a major access road to two hospitals and West Virginia University's football stadium. The five lanes are now open to traffic, and it is expected to be fully completed in the fall as student return to WVU's campus. This widening project should eliminate traffic congestion for the community.


PARTNER AGENCY UPDATE: MON RIVER TRAILS CONSERVANCY


Collins Ferry Connector

You can now enjoy this walk/bike connection to and from the Suncrest and Collin Ferry Road neighborhoods down to the Mon River Rail-Trail near mile 4.5. The Mon River Trails Conservancy will still be working on additional features over the next month, and we plan to wait until those are complete before hosting a ribbon-cutting event to celebrate this new neighborhood-trail connector. Stay tuned for the announcement date for the ribbon-cutting! The Collins Ferry Connector, which is less than a quarter mile, has a steep descent to the Mon River Rail-Trail. In West Virginia style, the ferry road was built into a mountain; it has narrow pinch points and steep banks. The newly compacted stone surface makes that journey much easier, but please go slow and stay alert. If biking, check your brakes at the top. Please share the trail with others; those coming down should yield to those coming up. The Collins Ferry Connector was once a section of the Pennsylvania, Morgantown, to Beverly Turnpike, which was constructed between 1836 and 1853 by the state of Virginia, and was later deeded to West Virginia when it became a state. As a wagon trail, it has a steeper slope than you usually experience on rail-trails. The Collins Ferry Connector project is partially funded by a grant from the Federal Highway Administration's Recreational Trails Program administered by the West Virginia Department of Transportation, Division of Highways. There have been many that have touched this project in the last 20+ years! Thank you to all that have worked to make this vision into a reality.

The city's annual Paving Program has been awarded to Parrotta Paving and is expected to commence soon. Additional ongoing projects include pavement assessment and the implementation of the Pedestrian Safety Plan.

PARTNER AGENCY UPDATE: CITY OF MORGANTOWN- PEDESTRIAN SAFTEY BOARD

The Morgantown Pedestrian Safety Board, led by Matthew Cross, advocates for a pedestrian-friendly environment throughout the City. Their last meeting was held on June 26th, and the next one is scheduled for the last Monday of August at 4:30 pm. These meetings are open to the public, and you can find the Microsoft Teams link on the city's website.



The Board is currently preparing for the return of students in the fall and hopes that WVU will promote walking and biking for first-year students and the general student body.

PARTNER AGENCY UPDATE: MOUNTAIN LINE TRANSIT AUTHORITY (MLTA)



Mountain Line is a publicly supported and funded transportation system serving Monongalia County. Kelli LaNeve from Mountain Line has provided the MMMPO with an agency update regarding their Vanpools.

Currently, there is one subsidized vanpool operational, and the Vanpool Program has received an additional \$20,000 in funding. The CMAQ subsidy provides this van's riders \$200 per month for 10 months. The goal of this program is to establish a total of 10 new vanpools to facilitate efficient transportation.
