Subject: October 2023 TIP Administrative Adjustment and Amendment

This memorandum is to document the amendments and administrative adjustments in the MPO's Transportation Improvement Program (TIP) for October, 2023.

WV DOH requested two TIP amendments: the Morgantown industrial park access road project and Star City intersection improvement at I-79 Exit 155. Both projects are non-groupable projects.

WV DOH requested TIP adjustments for adding three projects: Greenbag Multi-use path study, India creek I-bean project, and Brockway Ave project. WV DOH also request adjustments for increasing funding for three projects: Burrough St project, Dellslow Arch bridge replacement project, and West Run Road project.
