

PARTNER AGENCY UPDATE: MOUNTAIN LINE TRANSIT AUTHORITY (MLTA)



Mountian Line has provided the MMMPO with multiple updates:

- Mountain Line has two vanpools currently running, both traveling to Hazelton. These vanpools are utilizing the CMAQ subsidy.
- Mountain Line is also continuing rennovations of their terminal lobby. These renovations will include an expanded lobby, vending area, children's area, high-top tables and charging stations, informational monitors, and more.
- Mountain Line is continuing their microtransit service, called RideMon. There is a new app called RideMon that is specific to our service. It can be found on both IOS and Android. The dark green shaded area in the map below is where the RideMon service runs. It connects riders with transit options at Walmart on Grafton Rd, Giant Eagle on Greenbag Rd and the Sabraton Goodwill/Sheetz area.
- Mountain Line is working with consultants to conduct a Rider/Non-Rider Research Campaign to study changes in travel behavior due to third party ride-sharing services, post-pandemic increases in telecommuting, historically high fuel prices and other broader trends.
- Mountain Line's Citizen's Advisory Committee elected a new Chairperson, David Huffman. He is a frequent rider of Mountain Line and a long time member of the CAC. We are excited to have him serve as Chair.



PARTNER AGENCY UPDATE: CITY OF MORGANTOWN

The City of Morgantown has provided the MMMPO with multiple updates

- MORGANTOWN WEST VIRGINIA
- The Pleasant St Streetscape is currently under construction with Blue Gold Development as the contractor. The 1st St relocation project was bid out recently and should begin soon. This work complements the WVDOH Beechurst widening and Campus Drive relocation.
- The City of Morgantown's annual pavement preservation project is underway, with the contractor Parrotta Paving. Substantial completion is expected on October 17th.
- The Morgantown Traffic Commission meets next week and will consider initial recommendations for the pedestrian safety and sidewalk plan's early phase construction projects before sending said projects for broader review. Kimley-Horn is assisting the City's Public Works and Engineering department in their analysis of project candidates that will meet the initial goals and objectives set by the Commission and its Pedestrian Safety Board: high impact (existing high use or clear latent demand), benefits spread across all city neighborhoods, quick to implement, and safety motivated. This early construction phase will be concurrent with and is intended to spread awareness and encourage public participation in a year-long planning, implementation, and funding strategy analysis to address City Council's repeated demands for investment in ped / bike infrastructure.
- The City continues to refine its pavement preservation strategies and is gearing up to reassess its roads this fall.

PARTNER AGENCY UPDATE: CITY OF MORGANTOWN- PEDESTRIAN SAFETY BOARD

The Morgantown Pedestrian Safety Board (PSA) welcomes two new members. Traci Stead from the 6th Ward and Peter Giacobbi, Professor of Sport and Exercise Psychology who will represent WVU. Currently they are developing PSA's targeting students and the general public. They are also highlighting October as National Pedestrian Safety Month.



PARTNER AGENCY UPDATE: MON RIVER TRAILS CONSERVANCY

The Mon River Trails Conservancy is hosting a ribbon-cutting for the Collins Ferry Connector on Tuesday, October 3 at 1PM. All are welcome to celebrate this newest rail-trail connector. Ribbon-cutting will take place at the top of connector at the end of Collins Ferry Road followed by a guided walk to see how it links into the Mon River Rail-Trail.

MRTC is happy to announce that two trail counters were installed. One replaced an old counter at the WV/PA state line, and the other is on the newly opened Collins Ferry Connector.

Any urban area with a population greater than 50,000 citizens is required by Federal Statue to form a Metropolitan Planning Organization (MPO). The two main functions of an MPO are developing a Metropolitan Transportation Plan (MTP) and ensure that the use of federal funds for transportation projects aligns with the goals of the MTP.
