MPO STAFF UPDATE: JACKIE PEATE & THE COMMUNITY GARDEN PROGRAM

The MMMPO is working with the City of Morgantown to support Community Gardens. This program can assist with the purchase of tools and supplies to implement a community garden in neighborhoods. The reason for this program is that WVDOH is preparing to improve Greenbag Road and this project will eliminate an existing community garden that serves the residents of the surrounding area. The WVDOH and the Federal Highway Administration will provide up to \$15,000 to be distributed to at least three (3) community organizations (not individuals). Groups are welcome to apply for smaller grant amounts, allowing for the creation of more than three (3) gardens. For example, there could be five (5) organizations awarded \$3,000 each, \$5,000 is the maximum that can be awarded per organization. Applicants should ensure that the garden is sufficiently accessible to the community participants, and produce food products for the surrounding community.




WEST VIRGINIA VULNERABLE ROAD USERS ASSESSMENT FOR MORGANTOWN IMPROVEMENTS

Donna Hardy, PE, Assistant Director of Traffic Engineering for WVDOH made a presentation about Vulnerable Road Users at the March Policy Board Meeting. Below is a summary of the presentation.

Background

A Vulnerable Road User (VRU) is a non-motorist including pedestrians, bicyclists, other cyclists, or persons using a mobility assistance device (ex: wheelchair). This also includes highway workers on foot. A motorcyclist is not considered a VRU. The VRU study is an assessment of the safety performance of a State with respect to VRUs as required by the Federal Highway Administration. The State has prepared a plan to improve VRU Safety. There are average of 66 VRU fatalities and serious injuries in West Virginia every year. WVDOH held several public meetings and sent out surveys for the State's input as a part of developing the plan.



Results

The Public Survey asked two main questions, with 648 total respondents:

- What Barriers Discourage You from Walking or Biking?
- What Do You Think Are the Most Promising Investments for Road Safety?

Seventy three percent of participants said that lack of facilities discourage walking and biking, while sixty three percent of participants said that unsafe areas to cross traffic discourage walking and biking.



Sixty nine percent of participants said that more pedestrian infrastructure is the most promising investment for road safety, while fifty nine percent of participants said that more bike infrastructure is the most promising investment for road safety.

The State's Crash Data showed that in Mon County, there were 8 identified High Injury Networks. It was found that seventy one percent of the drivers involved with incidents were men. Seventy three percent of the VRU's involved in incidents were men. The top two VRU activities in fatal and serious injury crashes were pedestrian crossing mid-block at 32.5%, and pedestrian walking in travel lane at 23.6%. These crashes tend to occur at nighttime, and impairment played a big role in these crashes.

The Strategies and Next Steps include providing VRU accommodations along the High Injury Network and High-Risk Segments, educating road users on VRU safety, reducing vehicle speeds in areas with high VRU presence, updating crash reports for more specific VRU details, and a bi-annual reviews of VRU crash data and the status of strategy implementation. WVDOH is also focusing on improvements for Brookhaven Rd and Exit 155, in addition to other high priority projects and areas of need.

PARTNER AGENCY UPDATE: CITY OF MORGANTOWN- PEDESTRIAN SAFETY BOARD

PARTNER AGENCY UPDATE: MON RIVER TRAILS CONSERVANCY

The Foundry Street Link Project will use a city right-of-way to create a walking and biking connector between the Mon River / Caperton / Deckers Creek Rail-Trail and downtown Morgantown. The project has added new lighting and wayfinding signs for trail users on the Mon River Rail-Trails to connect downtown Morgantown and find other amenities on the 48-mile trail network. Lights were installed on the road overpass to shine on the start of the Deckers Creek Rail-Trail and route to Foundry and High Streets in downtown Morgantown. Four new wayfinding signs provide direction to restaurants, outfitters, and other services in the and destinations on the rail-trails. Two new totem signs mark the welcome entrance to trailhead parking at Sturgiss Street and Hazel Ruby McQuain Park. The Foundry Street Link Project is partially funded by a grant from the Federal Highway Administration's Recreational Trails Program administered by the West Virginia Department of Transportation, Division of Highways.
